TARGET MARKET DETERMINATION

1. About this document

This target market determination (TMD) seeks to offer consumers, distributors and staff with an understanding of the class of consumers for which this product has been designed, having regard to the objectives, financial situation and needs of the target market.

This document is not to be treated as a full summary of the product's terms and conditions and is not intended to provide financial advice. Consumer must refer to the Product Disclosure Statement (PDS) and any supplementary documents when making a decision about this product.

Product Disclosure Statement to which this target market determination applies

This TMD applies to the Global Natural Resources Fund issued by Janus Henderson Investors (Australia) Funds Management Limited (ABN 43 164 177 244) referred to in the Global Natural Resources Fund Product Disclosure Statement.

2. Class of consumers that fall within this target market

The information below summarises the overall class of consumers that fall within the target market for the Global Natural Resources Fund, based on the product key attributes and the objectives, financial situation and needs that this product has been designed to meet.

A consumer (or class of consumer) might intend to hold a particular investment product as part of a diversified portfolio. In these scenarios, the investment product should be assessed against the consumer's attributes for the applicable part of the portfolio, instead of against the consumer's portfolio as a whole.

The Global Natural Resources Fund is for those who are seeking to achieve long-term capital appreciation by investing in a portfolio of global natural resource companies operating in the mining, energy and agricultural natural resource sectors and across the upstream, midstream and downstream segments of the natural resources utilisation chain.

Product description and key attributes

The key product attributes of the Global Natural Resources Fund are:

- The Global Natural Resources Fund seeks to achieve a total return after fees that exceeds the total return of the Benchmark (S&P Global Natural Resources Index (net dividends reinvested) in AUD) over rolling five year periods;
- The fund seeks to provide exposure to a diversified portfolio of global natural resource companies operating in the metals and mining, energy and agriculture sectors. The Fund typically holds between 50-70 companies diversified by sector, market capitalisation and country;
- Income distributions are generally made on a semi-annual basis;
- A management fee of 1.10% per annum of the asset value of the fund is charged. A buy/sell spread may be charged when entering/exiting the fund; and
- Online access to investment details via Portfolio Online.

Objectives, financial situation, and needs

This product has been designed for consumers who:

- Are seeking capital growth through exposure to an actively managed global natural resources strategy;
- Are willing to pay the fund's management fee through the value of their invested capital;
- Would be comfortable to invest their capital for a minimum suggested timeframe of at least five years;
- Have a very high risk tolerance and are willing to accept the risks of losing some of their invested capital; and
- Need this product if they are wanting to gain exposure to an actively managed long only natural resources strategy that aims to outperform the benchmark.

Consistency between target market and the product

The Global Natural Resources Fund is likely to be consistent with the likely objectives, financial situation and needs of the class of consumers in the target market. This is based on an analysis of the key terms, features and attributes of the product and a finding that these are consistent with the identified class of consumers. Individuals will need to consider whether this product meets their specific objectives, financial situation and needs. The Fund aims to meet its performance target as assessed in relation to its objective and benchmark, and also aims to pay semi-annual distributions.

3. How this product is to be distributed

Distribution conditions/restrictions

Channel	Distribution condition
Platforms	The fund is available for distribution through investment, super or wrap platforms, and investor directed portfolio service (IDPS) or IDPS-like scheme or other trading platform where there is an arrangement between the issuer and platform which governs their relationship.
Advisers	The fund is available for distribution through a dealer group and/or a registered financial adviser either directly or via platforms where the dealer group and/or financial adviser has considered the customer's objectives, financial situation and needs, and is reasonably satisfied that the fund, or a diversified portfolio containing this fund is suitable for the customer.
Brokers	Distribution condition: The fund is available for distribution through the ASX mFund Settlement Service if i) the broker is registered with the ASX, and ii) the broker has considered the customer's objectives, financial situation and needs, and is reasonably satisfied that the fund, or a diversified portfolio containing this fund is suitable for the customer.
Direct	The fund is available via direct application if the customer has submitted a completed application form and read and accepted the PDS. The application form and PDS can be found on the Janus Henderson website.
