1. About this document

This target market determination (TMD) seeks to offer consumers, distributors and staff with an understanding of the class of consumers for which this product has been designed, having regard to the objectives, financial situation and needs of the target market.

This TMD applies to the Cash Fund - Institutional issued by Janus Henderson Investors (Australia) Funds Management Limited (ABN 43 164 177 244) referred to in the Cash Fund - Institutional Product Disclosure Statement.

2. Class of consumers that fall within this target market

The information below summarises the overall class of consumers that fall within the target market for the Cash Fund -Institutional, based on the product key attributes and the objectives, financial situation and needs that this product has been designed to meet.

A consumer (or class of consumer) might intend to hold a particular investment product as part of a diversified portfolio. In these scenarios, the investment product should be assessed against the consumer's attributes for the applicable part of the portfolio, instead of against the consumer's portfolio as a whole.

The Cash Fund - Institutional is for those seeking to gain exposure to an actively managed portfolio of high quality short term securities that provide investors with low risk exposure to secure cash investments and returns that closely track the prevailing level of short-term interest rates.

Product description and key attributes

The key product attributes of the Cash Fund - Institutional are:

- The Cash Fund Institutional seeks to achieve a total return after fees that exceeds the total return of the Benchmark (Bloomberg AusBond Bank Bill Index) over rolling annual periods;
- The fund is an actively managed portfolio of high quality short term securities that seeks to provide investors with low risk exposure to secure cash investments and returns that closely track the prevailing level of short-term interest rates;
- Income distributions are generally made on a monthly basis;
- A management fee of 0.10% per annum of the asset value of the fund is charged. The fund currently does not apply a buy spread or a sell spread, though a buy/sell spread may be charged when entering/exiting the fund; and
- Online access to investment details via Portfolio Online.

Objectives, financial situation, and needs

This product has been designed for consumers who:

- Are seeking capital preservation and income distribution through exposure to an actively managed portfolio of high quality short term securities;
- Are willing to pay the fund's management fee through the value of their invested capital;
- Would be comfortable to invest their capital for a minimum suggested timeframe of at least one year; and
- Have a very low risk tolerance and are seeking a high degree of liquidity.

Consistency between target market and the product

The Cash Fund - Institutional is likely to be consistent with the likely objectives, financial situation and needs of the class of consumers in the target market. This is based on an analysis of the key terms, features and attributes of the product and a finding that these are consistent with the identified class of consumers. Individuals will need to consider whether this product meets their specific objectives, financial situation and needs. The fund aims to meet its performance target as assessed in relation to its objective and benchmark, and also aims to pay monthly distributions.

Platforms	The fund is available for distribution through investment, super or wrap platforms, and investor directed portfolio service (IDPS) or IDPS-like scheme or other trading platform where there is an arrangement between the issuer and platform which governs their relationship.
Advisers	The fund is available for distribution through a dealer group and/or a registered financial adviser either directly or via platforms where the dealer group and/or financial adviser has considered the customer's objectives, financial situation and needs, and is reasonably satisfied that the fund, or a diversified portfolio containing this fund is suitable for the customer.
